OVERVIEW: SEXUAL ASSAULT PREVENTION & RESPONSE
(SAPR)

The Maryland Air National Guard Sexual Assault Prevention and Response Program reinforces the Air Force’s commitment to eliminate incidents of sexual assault through awareness and prevention training, education, victim advocacy, collaboration, response, reporting and accountability. The Air Force promotes sensitive care and confidential reporting for victims of sexual assault and accountability for those who commit these crimes.

Sexual assault violates good order and discipline, erodes unit cohesion, and destroys trust; directly impacting mission readiness.

The 175th is a premiere multi-domain wing providing lethal effects through combat airpower and cyber warfare; We provide innovative citizen Airmen ready to execute the National Defense Strategy, and support our partner nations, home communities and the state of Maryland.

The 175th Wing SAPR team is dedicated to the advocacy and support of survivors, ensuring they:

- Are protected and treated with dignity and respect.

- Receive timely access to appropriate medical treatment.

- Receive advocacy support.

- Have access to confidential services, including the SARC and Victim Advocates (VA).

SEXUAL ASSAULT REPORTING OPTIONS

Report a sexual assault to a Sexual Assault Response Coordinator (SARC) or SAPR Victim Advocate (VA). You can also disclose that you have been sexually assaulted to a Chaplain, healthcare professional or the Director of Psychological Health. ONLY SARC/SAPR VAs can accept official Restricted (RR) or Unrestricted (UR) Reports.

Know that an independent investigation can arise from their party disclosures. Commanders, First Sergeants, Supervisory Chain, Air Force Instructors, Law Enforcement, and Military OneSource are all Mandatory Reports and must report.
